



Requirements for Fireworks / Pyrotechnics displays within the City of Green Bay

The applicant will comply with all Wisconsin Statutes, City of Green Bay Ordinances, and NFPA 1123 (for Fireworks permit), NFPA 1126 (Pyrotechnics before a proximate audience permit), or NFPA 160 (Standard for flame effects).

The following items are required and **shall** be submitted to the Green Bay Fire Department's Fire Prevention Division no later than **15 days** prior to a fireworks / pyrotechnics display:

- City of Green Bay Fire Department Fireworks and Pyrotechnics users application
- \$150.00 permit fee.
- Certificate of Insurance naming the City of Green Bay as an additional insured for the display held under the permit in the aggregate amount of not less than \$5,000,000.
- List of ALL products being used. This list shall include number, size and brief description.
- An accurate site plan / layout of the event. All distances shall be marked on the site plan as well as location of display. A description of the event including times, etc. must be included with the site plan.
- Copy of US Department of Justice "Notice of Clearance" listing responsible person(s) and employees.
- List of all persons involved with the display.
- Material and Safety Data sheets for all products being used in the display.
- If products being used in the display have been manufactured by the applicant, a copy of the ATF licenses to manufacture must be included with the application.

The applicant will be notified at the time of receipt of the application if there are any concerns that need to be addressed. The permit will be signed and returned during the site visit, by a representative of the Green Bay Fire Department. A site visit form will also be filled out and a copy supplied to the vendor at the time of the scheduled walk through.

2. To furnish the Green Bay Fire Department with a list of all fireworks/pyrotechnics prior to use and copies of operator's credentials.
3. This permit is valid only for the date and rain date listed herein.
4. The applicant will comply with all Wisconsin Statutes, City of Green Bay ordinances, and NFPA 1123 Code for Fireworks Displays (for fireworks permit) or NFPA 1126 Standard for Use of Pyrotechnics before a Proximate Audience (pyrotechnics permit) or NFPA 160 Standard for Flame Effects.
5. To file a Certificate of Insurance naming the City of Green Bay as an additional insured for the fireworks/pyrotechnics display held under this permit in an aggregate amount of \$5,000,000.00 or more, specific to the date and type of activity, not less than 15 days prior to the issuance of this permit.
6. A violation of any of the terms and conditions herein shall be cause for immediate revocation of this permit and subject the applicant to any citations or fines as allowed by Wisconsin Statute or City of Green Bay ordinance.
