

HOLD HARMLESS AGREEMENT

THIS AGREEMENT is made in the City of Green Bay, Brown County, Wisconsin, by and between the CITY OF GREEN BAY, WISCONSIN, a municipal corporation (“CITY”), and “DOG OWNER” identified as:

WHEREAS, the City of Green Bay is seeking the assistance of dogs and their owners for the purpose of humanely attempting to remove geese from Leicht Memorial Park; and

WHEREAS, DOG OWNER has contacted the CITY and volunteered to participate in such activity; and

WHEREAS, CITY has granted to DOG OWNER an exemption to Green Bay City Ordinance 25.04(8) which prohibits any domesticated or privately-owned animal from being present at any City park; and

WHEREAS, such exemption is specific to Leicht Memorial Park and specific to this activity involving removal of geese.

NOW, THEREFORE, in consideration of the covenants and promises hereinafter set forth and other good and valuable consideration acknowledged by the parties herein, it is agreed as follows:

1. CITY grants to DOG OWNER permission to enter Leicht Memorial Park with their dog(s) for the dog(s) to play within Leicht Park.
2. DOG OWNER will be responsible for cleaning up any animal waste from their dog(s).
3. DOG OWNER attests that the dog(s) listed above has/have not bit anyone and are up to date with all vaccinations, including rabies.
4. DOG OWNER will be responsible for any damages or injury caused by their dog(s) in Leicht Memorial Park.
5. DOG OWNER shall assume liability for, be responsible for, indemnify and at the CITY's request, defend and save harmless the CITY, its employees, officials and agents, and anyone to whom it may be liable by contract or otherwise, against any loss, damage or expense, including attorney's fees, investigative and discovery costs and court costs, sustained or incurred because of or by reason of any and all claims, demands, suits, actions, judgments and executions by whomever and whenever made or obtained, allegedly caused by, arising out of or relating to in any manner this Agreement, including any loss, damage or expense caused in part by the CITY's negligence except a loss, damage or expense caused solely by the CITY's act or negligence or solely by a third party's act or negligence while DOG OWNER was at all times diligently trying to minimize the risk of the loss, damage or expense.
6. CITY may terminate this Agreement for any reason upon written notice to DOG OWNER.
